Just this month it announced that "WoW Classic," or the original version of the game from its release in 2004, would receive a major update at the end of the summer. This patch, first teased in the spring, will include classes like the druid and rogue, as well as new battlegrounds, quests, and other content. Now Blizzard's chief technology officer J. Allen Brack has told Polygon that an update for the already-existing World of Warcraft is in the works for Q1 2019. The existing version will allow players to access all the same content -- or would, if Blizzard's schedule was still in any way reliable. "We're kind of still in a tuning mode right now," Brack says. "We've got so much stuff to

do with the next update, things are moving so fast. We're still in active development." Still, after three years of trying to get its original game to work on modern computers, it's hard not to feel some shock when there's a new patch or a newly announced update coming in six months' time. Brack says that the reality of working with the very early access nature of World of Warcraft means that many features are still being integrated into the game, even after they're officially released. "We don't give too much advance notice about what we're doing," Brack says. "We're always in developer mode, with a ton of stuff going on, but we can't necessarily announce it." Meanwhile, though, Blizzard is building up the World of Warcraft: Warlords of Draenor 2.0 update for the next big subscription expansion, Shadow
